Receive your reward

Earnings will be paid off by check* in April 2022 (invoices submitted in March 2022), July 2022 (invoices submitted between April 1 and June 30), October 2022 (invoices submitted between July 1 and September 31) and February 2023 (invoices submitted between October 1, 2022, and January 31, 2023). Maibec reserves the right to delay payment for reason beyond its control.

Maibec will issue the rewards in the form of a cheque* to the applicant in the company's name. Rewards are paid in CAD dollars.
